

## "Bring A Friend!" Official Contest Rules

**Introduction:** ASIS International ("Contest Sponsor") is offering this promotion (the "Contest") to registered attendees of Global Security Exchange (GSX) 2018 only. By participating in the Contest, each entrant fully and unconditionally agrees to and accepts the below contest rules (the "Official Rules").

Contest Sponsor: ASIS International, 1625 Prince Street, Alexandria, VA 22314, USA.

**Eligibility:** Open to registered attendees of Global Security Exchange 2018 who are at least 18 years old. Global Security Exchange exhibitors, personnel, vendors, ASIS International staff, and their respective related companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each of the aforementioned are not eligible. The Contest is subject to all national, federal, state, provincial, and local laws and regulations. Winning the Contest depends on the number of eligible entries received.

How to Enter: There is no purchase necessary to enter. To be entered in the Contest: (1) registered attendees must invite a colleague or friend at least 18 years of age to GSX 2018 through an InGo message on Twitter, Facebook, or LinkedIn; and (2) the individual invited must register for GSX 2018 during contest period. Attendees will become eligible entrants in the Contest when the individual invited completes his/her GSX 2018 registration, including naming the registered attendee who invited him/her. The winner of the Contest will be the attendee who is named as their "inviter" by the most number of people registered for GSX 2018 through InGo during the official contest period. In the case of a tie the winner will be randomly selected. To be entered, attendees must be registered for GSX 2018 before their invitees register.

Contest: The Contest starts on 16 July, 2018, at 12:00am EDT and will end 20 August, 2018, at 12:00pm EDT. For details on how to enter, please see the "How to Enter" section above. The Contest Sponsor will notify the Contest winner by email and will announce the winner on social media of Contest Sponsor's choosing. The winner will have (48) hours from announcement or direct notification (whichever is later) to claim the prize specified below by emailing marketing@asisonline.org. The eligible entrant selected must comply with all terms and conditions of these Official Rules as winning is contingent upon fulfilling all requirements. If the winner cannot be contacted within two business days after the first attempt to contact him/her, if he/she does not follow these Official Rules, or if he/she fails to sign and return the affidavit of eligibility and liability/publicity release within the required time, the winner shall forfeit the prize described below and the eligible entrant with the second highest number of registrations will be selected.

**Prize:** One (1) Grand Prize will be awarded to an eligible entrant, provided "as is" with no warranty, express or implied given by Contest Sponsor.
