



## GLOBAL ACCESS LIVE! WATCH PARTY OFFICIAL CONTEST RULES

NO PURCHASE REQUIRED TO ENTER OR WIN.

**Introduction:** ASIS International ("Contest Sponsor") is offering this promotion (the "Contest") to security professionals only. By participating in the Contest, each entrant fully and unconditionally agrees to and accepts these Official Rules.

**Contest Sponsor:** ASIS International, 1625 Prince Street, Alexandria, VA 22314, USA

**Eligibility:** Open to global security professionals who are at least 18 years old. Global Security Exchange (GSX) exhibitors, personnel, vendors, ASIS International staff, and their respective related companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.
